1. PROPOSAL FOR THE PUBLIC ARTS COMMISSION TO SPONSOR THE MARY PICKFROD THEATRE FILM SERIES

Background: Ted Hane, General Manager of the Mary Pickford Theatre, informed us that a film program that used to be at the Cinemas Palme D'Or in Palm Desert has now signed on with the Mary Pickford Theatre starting in February. The program brings in directors, producers, writers, composers and sometimes actors of current major movies to the theatre to help promote the movies in the Valley and bring visitors to Cathedral City. The first film of the series is scheduled for February 4 featuring the movie, "A Dog's Purpose." Writer W. Bruce Cameron and his fellow screenwriter and wife Cathryn Michon along with their dog will appear for the film series to answer questions from the audience. On February 18th, the film series brings Oscar Nominated Composer Justin Hurwitz for the screening of "La La Land."

Recommendation: Vote on a proposal with a budget not to exceed \$1,000 for up to 4 film screenings. Each film screening sponsorship would be \$250.
